

## **BAR OF THE RINCON CIVIL TRIAL COURT**

### **APPLICATION FOR ADMISSION**

To be eligible to practice law before the Rincon Civil Trial Court, an attorney must be admitted annually to the Rincon Band Bar of the Civil Trial Court.

#### Eligibility and Application Requirements

To be eligible for admission to the Rincon Band Bar of the Civil Trial Court, an attorney must:

- Be a member in good standing of any state or tribal bar with no disciplinary proceedings pending
- Conform to the standards of conduct promulgated by the American Bar Association in the current Model Rules of Professional Conduct in the performance of his or her professional duties
- Be knowledgeable of applicable federal, state, and tribal law as well as the Rincon Civil Trial Court Code of Civil Procedure, RTC § 3.310, and Rules of Court, RTC § 3.320
- Consent to review of his or her attorney's fees for reasonableness by the Court Administrator of the Civil Trial Court, if attorney's fees are requested
- Understand that should he or she be found in contempt of court by a judge of the Rincon Civil Trial Court, the judge may levy a fine of up to \$500.00 per incident, and failure to pay the fine within 20 days of issuance will disqualify him or her from membership in the Rincon Band Bar of the Civil Trial Court until such time all fines are paid in full
- Agree to pay an annual bar membership fee of \$200.00 due January 1<sup>st</sup> (Fees not timely received by February 1<sup>st</sup> will increase to \$250.00.)

Attorneys seeking admission to the Rincon Bar of the Civil Trial Court must submit:

- A completed application for admission
- A non-refundable application fee of \$200.00
- Acceptable proof of membership in any state or tribal bar
- Proof of malpractice insurance, including insurance carrier, policy number, and expiration date of coverage
