WHEREAS, GIRMAI, upon the advice of and after consultation with, counsel, wishes to dismiss the entire action with prejudice against Defendants and any related entities.


WHEREAS, Defendants have agreed to waive any request for costs against GIRMAI in exchange for GIRMAI's dismissal of the entire action with prejudice.
